# Public Survey Results

The Public Survey was active for six to eight weeks during the last quarter of 2024 and was distributed through email, at First Friday events, and on the Regional and municipal websites.

# **424** Survey Responses

## representing 27,160 Oxford Region Residents 1.5%

### of the total Population

86.80% of respondents are **Resident Property Owners** 

Of those who responded, **41.7%** are **Adults**, **30 to 54**.

**23.4%** of respondents have lived in the Oxford Region for **21-30 years**, **31.3%** for **31-50 years**.

**21.8%** of respondents chose to live in the Oxford Region for the **Attractiveness** and/or **Rural Character** of the area.

**East Nottingham** had the highest number of respondents at **39.4%**.

23.2% said Good, 17.3% said Excellent, 3.6% said Fair, 0.5% said Poor The top answer when Respondents were asked to describe the **Quality of Life** in the Region was Very Good at **55.4%**.

**60.8%** of respondents said they **live next to a farm**, **31.8%** said they **did not live next to a farm**, and **6.9%** said they **lived on a farm**.

The vast majority (**93.6%**) of respondents said they live in a **single-family home**.

Of the respondents who answered the question, **33.5%** said that **we have enough affordable housing**, **40.1%** said we **need more affordable housing**, and **26.4%** said **they were not sure**.
